Members update

We've now got 55 members as seen in the **Members Report**.including the latest that joined in the last couple of days- West Lothian Litter Pickers, The Verdancy Group and West Calder and Harburn CDT.

WLCAN Hub update for end of financial year 2023/24

Neil shared a **Presentation** on the 2023/24 financial year. This covered the launch Gathering at the end of Jan, which was well attended with 32 organisations represented. The original 14 ECO Fund projects were increased to 17 by persuading the Scottish Government that we could vire between costings to make the **Final Awards** of nearly £46k. There will be £10k to disperse for next year.

The new Directors were introduced who gave a short bio - Sarah Madden who will be taking up a post with Woodland Trust Scotland, Amanda Webb our Youth representative, and Pauline Stafford a WLC Councillor and musician, The other two Directors that were unable to make the meeting were Graham Clark who was Director of Computing, Engineering and Built Environment at West Lothian College and project leader for the ECO House, and Harry Cartmill a WLC Councillor.

Events will be held throughout the year on the elemental themes of Earth, Water, Fire and Air. The first will be a Food growers and producers event on Monday 24th June at West Lothian College. This was given priority as most of the ECO fund projects were for community gardens, food growing and woodlands.

There have been 2 Newsletters produced - the **Gathering News** and the **April Newsletter**.

There has been an opportunity to highlight some of our members' efforts and accomplishments. We've asked groups to submit reports along with any relevant images. Good quality pictures are especially valuable, as they can make for compelling media stories. Please continue to send in your

reports, and provide a brief narrative to accompany the images. These reports will be featured on our new **website** ensuring that all groups are recognized for their contributions. We want to meet with you all, learn about your stories, and share your progress.

In the second page of the newsletter there were updates on various campaigns. We aim to engage members and gauge their opinions on issues that matter to them. We'll also be using newsletters to announce upcoming events and provide regular updates on our work.

In terms of social media, we're connected with most of you. If you're not already following us, please do so. We've had to start a new **Facebook page**, as we didn't have full control over the previous one. While Facebook is the most widely used platform locally, we plan to expand our presence on other social media platforms as well.

WLCAN Grant Award for 2024/25


WLCAN has been awarded £160k for financial year 2024/25 which includes an uplift of £10k for an ECO Fund. We are still looking at ideas on how the ECO Fund is used this year and if it can be match funded in some way. Key strategic activity areas were shared in the slides.

There was a discussion on the contribution energy companies can make to the Hub as they would like to be involved in Community Sustainability projects.

Climate Education and Training
